Minutes

1) <u>Call To Order</u>– Jamie Travis, Chair of the Board of Trustees, convened the regular meeting on Wednesday, January 27, 2021 at 3:01 p.m.

The following Board Members were present: Jamie Travis, Mary Lou Flynn-DuPart, Stephen Holmes, Rick Price, Wayne Mallia, Caroline Rickaway and Vivian Renfrow.

The following Board Members were absent: Lori Rickert, Excused and Jaime Castro, Excused

Also present were: Melissa Meadows, CEO – Gulf Coast Center, Sgt. Michael Vandergrifft-Brazoria County Sheriff's Office, Barry Goodman-The Goodman Corporation, Diane Terrell-Eide Bailly, LLP and several Center staff.

- 2) Citizens' Comments: None
- 3) Program Report: Diane Terrell, CPA Eide Bailly LLC presented the Center's FY20 Financial and Compliance Audit. Ms. Terrell presented the various report schedules; noted that they were presenting an unqualified opinion; and stated that again there were no State or Federal findings or management letter comments. Ms. Terrell commended the Center's financial staff members for their assistance during the audit, as well as their work. As in previous years, in the next month or so, Ms. Terrell will send over comparative audit data using the eleven community centers' information from their firm's audits for review by the Board and staff's members.

- b. Texas Council Risk Management Fund: Next Board Meeting will be February 2021
- 5. Operations Report: Melissa Meadows, CEO
 - Q1 FY21 Board Report: Melissa Meadows, CEO, reviewed each slide and discussed data points depicted for the first quarter of Fiscal Year 2021.
 - COVID-19 Update: Sarah Holt, CNO, provided an update on COVID-19 precautions that remain in place, as well as summarized on-going efforts to secure vaccination opportunity for staff.
- 6. Budget, Finance and Admin Reports:

- **a.** Financial & Operational Monthly Report & YTD Summary: Rick Elizondo, CFO, provided a summary for the Month of December 2020 with revenues exceeding expenses by \$83,267.70 and Year to Date surplus of \$261,605.57.
- **b.** Sale of Property Update: Jones Building: Rick Elizondo, CFO, stated that the Center closed today, January 27, 2021 on the Jones Building.
- c. Galveston County Transit District/Connect Transition Update: Rick Elizondo, CFO, reported that Galveston County Transit District held the Virtual Ribbon Cutting on January 14, 2021 and the video is online for viewing.
- d. Corporate Compliance Annual Training & Report: Linda Bell, General Counsel, provided a brief training and discussed the Corporate Compliance Annual Report. The Center has had the benefit of the same Corporate Compliance Officer since its inception in 2002 which allows for consistency in handling corporate compliance issues. Stark Law, Anti-kickback law and False Claims Act and associated penalties are the primary areas of concern. During FY20, four compliance issues were reported which affected 18 individuals (3 incidents affected 1 person, while 1 incident affected 15). Incidents were related to human error and pertained to improper authorization or information being released to the incorrect entity/person. There were no associated Medicaid refunds/paybacks. The compliance committee meets quarterly and reviews: compliance reports, incidents, and investigations as well as Business code of conduct violations, audit findings, QM activities, D/A testing, HITECH Breach Notification issues, MIS Security Risks/Education and licensure verifications; exclusions and background check issues. While it would appear optimal to have no reported compliance issues, that is not the goal. Human error at a minimum is expected...0 reports would imply the Center's corporate compliance program is ineffective and not taken seriously by staff. The Corporate Compliance Officer continues to train staff annually to assist in the commitment to reducing the risk of improper, unethical, and unlawful conduct by staff.

On motion by Mary Lou Flynn-DuPart, seconded by Caroline Rickaway, the board voted the approval of the above Providers of substance use residential treatment services for the remainder of 2021. The motion carried with all members voting in favor.

d. Consider the approval of a decrease in the Center's milage reimbursement rate from \$.575 cents/mile to \$.56 cents per mile effective January 1, 2021 for any mileage paid on or after this date. The revised rate is consistent with the IRS allowable mileage rate for use of personal vehicle, as well as the State of Texas Comptroller's travel policy, both which were revised effective January 1, 2021 to the \$0.56 cents per mile rate.

On motion by Mary Lou Flynn-DuPart, seconded by Rick Price, the board voted the approval of a decrease in the Center's mileage reimbursement rate from \$.575 cents/mile to \$.56 cents per mile effective January 1, 2021 for any mileage paid on or after this date. The revised rate is consistent with the IRS allowable mileage rate for use of personal vehicle, as well as the State of Texas Comptroller's travel policy, both which were revised effective January 1, 2021 to the \$0.56 cents per mile rate. The motion carried with all members voting in favor.

e. Consider approval of the FY21 Amendment #4 to the HHSC IDD performance contract #HHS000608400001. This amendment adds \$65,298 for Enhanced Community Coordination services provided for the period January 1, 2021 – August 31, 2021.
